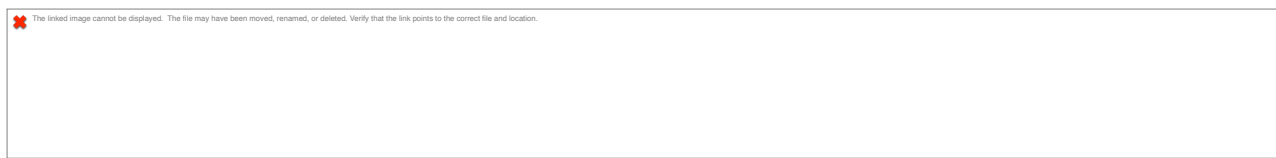
The statutory regulations state that a pecuniary interest is a “disclosable pecuniary interest” in relation to a Member if:
